## Terms and Conditions for engagement of Service Providers in Organic Farming Scheme under RKVY, 2012-13

1. The candidate must be a graduate in any discipline with basic computer knowledge.

However, preference will be given to the candidates –

i) Having training on Agriculture/ Organic Farming/ Service Provider/ work experience as Service Provider in Organic Certification programme &

ii) With rural background.

2. Candidates must belong to the particular district of the Organic farm for which candidature is offered. One candidate will offer his/her candidature for single Organic farm only .

3. The engagement will be purely on contractual basis for a period of one year only @ Rs.8000.00 (Eight thousand) only per month as remuneration. The Service Providers will not be entitled to claim for regular appointment/ absorption in the Government Service.

4. The Service Provider is to deliver his service for about 100(one hundred) number of farmers in 50(fifty) hectare cropped area spread in 1-3 number of adjacent clusters per constituency.

5. The Service Provider will be entitled for one day of paid casual leave for each completed month of service. The casual leave may be accumulated during the contract period subject to a maximum of 12 (twelve) days and will be exhausted with the 1 (one) year period.

6. The concerned DDO (SDAO) will pay the aforesaid remuneration within 1<sup>st</sup> week of every month after obtaining satisfactory performance report as well as absentee statement from the concerned ADO.

7. The Director of Agriculture reserves the right to terminate the contractual engagement at any point of time if it is found that the services rendered by the Service Providers are not satisfactory.

8. One Selection Committee will be constituted under the Chairmanship of Director of Agriculture, Assam (verbal interview) for selection of eligible candidates and the date and time of interview will be communicated through telephone and /or postal service. No TA/DA will be provided for attending the interview.

9. Original copies of attested certificates and other testimonials attached with the standard application form along with the contact number are to be shown during the interview.

10. Any application received after the last date of submission will not be considered.
