


#### Guide lines for Implementation.

1. Demonstration is to conducted in cluster of 10 hac and each Beneficiaries will get input for 0.4 hac.
2. Programme is to be Implemented involving PRI ( Panchayat Raj Institute ) as per RKVY Guidelines.
3. Preferance is to be given to the field organised under recently organised pathar parichalana samity (Field management Committee).

#### Terms and conditions

1. The quality of seeds should be in conformity of the seed Act, 1966 and seed control order, Govt. of India. Seed not conformity to the same will be rejected.
2. Germination test of these seeds must be done before distribution at Assam Seeds Certification Agency (ASSCA) and a copy of the certificate of ASSCA on the test must be produced to the under signed before starting the supply. Kindly note that seeds with germination percentage more than 85 % are entitled for supply.
3. All the seeds supplied must have validity period of at least 6 months from the date of Supply.
4. 2% performance security (2% of the allotment amount) is to be deposited in the form of Bank Draft in favour of Director of Agriculture, Assam, Khanapara, Guwahati-22 before supplying of inputs.
5. If non-standard seeds are supplied, no payment will be made, further the performance security will be forfeited.
6. No split bills will be accepted.
7. All challans must be duly countersigned by Respective DAO.
8. No revalidated seeds are allowed.




