
Sir,



- 1 Seeds is to be supplied and should be in conformity of the seed Act, 1966 and seed control order, Govt. of India. Seed not conformity to the same will be rejected.
  - 2 Germination test of these seeds must be done before distribution at Assam Seeds Certification Agency (ASSCA) and a copy of the certificate of ASSCA on the test must be produced to the under signed before starting the supply. Kindly note that seeds with germination percentage not less than 75 % for Lentil are entitled for supply.
  - 3 All the seeds supplied must have validity period of atleast 6 months from the date of Supply.
  - 4 2% performance security (2% of the allotment amount) is to be deposited in the form of Bank Draft in favour of Director of Agriculture, Assam, Khanapara, Guwahati-22.
  - 5 If non-standard seeds are supplied, no payment will be made, further the performance security will be forfeited.
  - 6 No split bills will be accepted.
  - 7 All challans must be duly countersigned by Respective DAO.
  - 8 No revalidated seeds are allowed.







## Guidelines for implementation of different Rabi Programmes under RKVY, 2013-14

1. Beneficiaries for each Rabi Programme of RKVY are to be selected in consultation with concerned newly organized PPS & local PRI.
2. Sites for each programme should be selected on the basis of feasibility of the particular crop. No PPS should be selected for more than one similar intervention from different scheme in a particular season. For example, if one PPS is selected for Rice or Potato or Lentil etc. demonstration from one scheme in Rabi for the year 2013 the same PPS should not be selected for same crop demonstration from any other scheme in this Rabi season, 2013. However, other benefit like STW, Power Tiller, WHS may be given which are not in similar nature.
3. For visual impact, demonstration must be conducted in compact basis preferably 10 Ha size and each beneficiary will get benefit of maximum 0.4 Ha.
4. All the inputs as per allotment are to be received by concern SDAOs but all the Challans (for all schemes) of all Sub-division of the district must be countersigned by respective DAOs and Challans (in original) are to be handed over immediately to the suppliers so as to enable the Directorate for timely payment of bills failing which claim will not be entertain for payment of Bill after due date.
5. Inputs are to be stored for distribution to farmer in the hired godown/store house rented for this purpose as per this Directorate letter No. Agri/RKVY/187/Rural Godown/2013-14/23 dtd. 30-9-2013. In addition to this godown, DAOs/SDAOs may avail the facility of storage in ASC Ltd. Godown.
6. DAOs are to submit weekly arrival inputs report in each Monday to this Directorate by special messenger or through E-mail address ([rkvyassam@gmail.com](mailto:rkvyassam@gmail.com)) by collecting same from sub-division concern.
7. Inputs received inferior quality, and also after the stipulated time must be avoided. Any such practices detected, will be dealt strongly by Govt.
