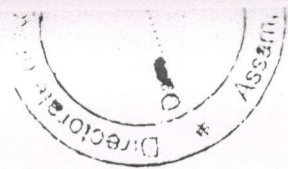

Sub : Sanction of State Share for Rs.61.82 lakh (Rupees Sixty one lakh and eighty two thousand) only for the Scheme Paramparagat Krishi Vikash Yojana (PKVY) under National Mission for sustainable Agriculture (NMSA) for the year 2016-17.

Sir,

With reference to above, I am directed to convey the sanction of the Governor of Assam for an expenditure not exceeding Rs.61.82 lakh (Rupees Sixty one lakh and eighty two thousand) only for the Scheme Paramparagat Krishi Vikash Yojana (PKVY) under National Mission for sustainable Agriculture (NMSA) for the year 2016-17 as State Share against the Central Share for an amount of Rs. 556.39 lakh subject to availability of fund and as per fund released by the Government of India vide their letter No.9-29/2015-Org.Fmg. dtd 28.08.2015 for General Category.

The following conditions shall strictly be followed while drawing fund, incurring expenditure and implementing the above scheme by the implementing authority:

- All the financial rules, procedures and formalities as per Assam Financial Rules.
- The Central Vigilance Commission's guidelines.
- Comply with all the provision of the AFRBM Act, 2005.
- VAT shall be deducted at the source and deposited into the State Exchequer by Treasury Challan.
- Ensure that the scheme is completed within the estimated cost in all respect without involving cost and time over run.
- Submission of the Utilization Certificate in due time.
- Procurement of goods and services to be done through e-Procurement as per O.M.FEB (e GU) 03/2015/61, dtd 05.08.2015 of Finance (Estb.B) Department.
- As per the conditions laid down by the GoI vide their letter No.9-29/2015-Org.Fmg. dtd 28.08.2015
- All other general conditions of financial propriety and fiscal discipline.

The expenditure is debitable to the Head of Account, 2401-Crop Husbandry, -00-104-Agricultural Farms, 4891- National Mission on Sustainable Agriculture-000-32- Grants in Aid General -99-others State Share (plan) for the year 2016-17.

This issues as per power delegated under DFP Rules, 1999 (as amended).
