

Terms and Conditions

1. The EOI shall be scrutinized by the team of selection committee and the final selection will be made by the selection committee chaired by the Director of Agriculture, Assam.
2. The successful Regional council (RC) shall have to execute a formal agreement on stamp paper worth Rs. 100.00 in the prescribed format within 7 (seven) days of selection.
3. The selected RC shall have to transfer/upload the farmer-details and other related document need for PGS certificate in the PGS portal in liaison with previous RC for Assam i.e. Horticultural Research Station, AAU, Kahikuchi, Guwahati and facilitating agencies viz. SIMFED, Gangtok and ICCOA, Bangalore.
4. Preference will be given to those active RC having office in Assam.
5. Preference will be given to the RC having registered local group and experience in PGS certification works in Assam/ NE States.
6. The undersigned reserves the right to accept or reject any or all proposal without assigning any reason thereof.
7. In case of any dispute arising between the parties hereto in respect of this EOI the suit on that behalf shall be subject to the jurisdiction of Guwahati High Court only.
8. The facilitating agency working in 220 nos of cluster shall not be considered as RC.
